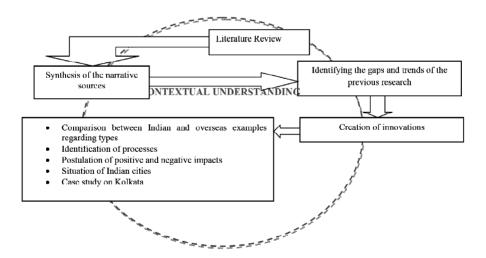


Figure 1 Methodological flow chart

Following discussion of this paper is basically based on literature based reviews of previous research. The methodological flow chart reveals the total pathways of this paper (Figure 1).

There is a temporal dimension to all of this, for arguably pioneer gentrification ideologically and practically has more positive aspects associated with it than later waves of gentrification. For example, pioneer gentrifies desired social mixing Butler and Lees (2006). Whereas, second and especially third wave gentrifies are much more individualistic. However, arguably it is pioneer gentrifies who initiate processes of displacement, even if this is not a deliberate behaviour. Loretta Lees, Tom Slater, and Elvin Wily stated positive and negative impacts of Gentrification in the Gentrification Readers, as follows (Table 2).

# **Gentrification in India**

India's urban transformation is continuing on its peri-urban borders through a great many little land exchanges. Presently, Gentrification is going on a more scale in Shanghai or Mumbai than in the more seasoned post-industrializing urban communities of Europe, North America and Oceania. In view of the arrangement proposed by various researchers with respect to Gentrification following typology can be created.

# **Classical Gentrification**

This explains the redevelopment in the form of demolishing individual buildings or groups of buildings. These plots are being redeveloped into high end commercial or residential spaces. Numbers of transformation like this can be found in Mumbai city in India. Here on this matter good example can be traced out through Kolkata where conservationists are angered over the partial demolition of a house with a history. Very recently near in Kalighat, Kolkata a heritage building found started to be demolished on October 12, 2018 when courts were on Puja vacation (Times of India [TOI], Oct 22, 2018). The youngest heir of the family has now alleged that a developer, to whom other family members illegally sold off their portions, embarked on the demolition although he had won a case at a lower court for retaining the house that was willed to the family in perpetuity.

#### **Commercial Gentrification**

It happens totally with commercial purpose from low end to high end development to fulfil the business intensions. That is again can be found at the junction of Middleton Street and Russell Street in Kolkata where a demolition brigade hammered down the terrace of a heritage hotel in the heart of the city to clear the site for the construction of a 35 storeyed residential tower. The demolition has drawn criticism from conservation activists and architects (Times of India [TOI], Mar 1, 2018) such examples are very common right now in other metro cities of India.

#### **Recreational Gentrification**

Good example of slum transformation can be found in Ahmedabad. Where removal of slum along Sabarmati river and conversion of riverfront into recreational areas has been done. Recently redevelopment of Dharavi slum in Mumbai remark the path so clinically. The new plan to redevelop Dharavi increases that density to inhumane proportions. Although the tower-block buildings offer amenities such as toilets, they also threaten to destroy the fabric of a community in which homes, roofs and outdoor spaces transform into places of work and social interaction – the only way many of the micro-enterprises can operate ( https://www.theguardian.com ).

# **Rural Gentrification**

Rural Gentrification can be assigned in rustic Bolpur zone in Birbhum district

of West Bengal. This region is known for Rabindranath Tagore and Visva-bharati University. It is wealthy in social legacy, crafted works and for its rustic excellence. Over the timeframe, provincial Bolpur has pulled in visitors as well as has step by step molded for the tip top Bengali people group.
